

## Family Support Membership (FSM) Agreement & Terms

This Membership Agreement (“Agreement”) is made between AK Lawyers Ltd, trading as April King (“Organisation”), and you, the Member (“Member”), effective upon payment of the Membership fees.

By joining the FSM, you agree to the Terms specified below. We may amend these terms and conditions periodically and will notify you in writing of any changes.

### Member Benefits

As an FSM Member with April King, you will receive the following benefits:

- A dedicated freephone helpline for your executor(s) at the time of your death.
- Free storage of Wills, Deeds, and Lasting Power of Attorney documents upon request.
- A 10% discount on future Will amendments or Power of Attorney services with April King (excludes third-party fees or disbursements).
- Up to 2 hours of legal support (verbal) for your executors at the time of death to provide guidance and assistance.
- Member updates and news.

### Current Fees

- Couple Individual Lifetime Membership: £240 + VAT @ 20%
- Individual Lifetime Membership: £120 + VAT @ 20%
- Couple 12-Month Membership: £80 + VAT @ 20%
- Individual 12-Month Membership: £40 + VAT @ 20%

### Annual Terms

Annual membership fees are fixed for a 12-month period and do not automatically renew unless you opt into a direct debit payment plan. The yearly direct debit will continue until you cancel. We reserve the right to update our fees upon renewal of annual membership. Any changes will be communicated before your next payment.

### Restrictions

The Member agrees not to:

- Reproduce or share any information received as part of their Membership with non-members, including these Terms.
- Publish any inappropriate, inaccurate, or offensive content regarding the Membership.

## Limitations

- April King advises only on Wills drawn up by the Organisation or its previous associate firms.
- April King does not provide taxation advice. Clients, executors, and beneficiaries should seek independent financial advice regarding taxation and any potential liability.
- Membership is open to clients of April King aged 18 or over.
- Only the Member (client) is entitled to discounted legal fees with April King. The discount must be requested at the start of the instruction. Failure to notify us may result in the discount not being applied.
- The discount cannot be combined with other offers or discounts and is subject to our standard terms and conditions.
- Advice will only be provided to lay executors, not to professional firms or firms acting on behalf of lay executors.

## Liability

At the time of death, we provide advice and guidance to your executors regarding the steps to execute the Will. This does not constitute a formal instruction. April King is not liable for any mistakes or omissions made by lay executors in the administration of the estate/probate or any losses incurred by clients, executors, beneficiaries, or third parties as a result thereof.
